#### Announcing the Four Star Commodore Award Program



The Florida Commodores Association is proud to announce the Four Star Commodore Award. The purpose of this program is to reward Past Commodores who have served their club, or their community on behalf of their club, at a level above the normal duties and responsibilities of a Commodore and have distinguished themselves as yacht club Commodores.

Starting in February, FCA will be sending a flyer to yacht clubs in Florida announcing the Four Star Commodore Award Program. Clubs who are interested in nominating one of their Past Commodores will be able to download the nomination forms from the FCA website. Each club will only be able to nominate one Past Commodore each year. There will be no cost to the club since all costs of the program will be bourne by FCA.

Every club is free to decide the manner in which they will select candidates for nomination. It could be done by their governing Board or a committee selected by their governing Board or the Commodore. Clubs also are free to decide the criteria which will be used in selecting a nominee. Membership in FCA is not a requirement to be eligible for an award. Nominations along with supporting documentation must be received by FCA no later than July 31, 2011. FCA will notify those selected for the Four Star Award and their clubs by November 30. Up to three awards may me made each year.

The awards will be presented by one or more FCA officers at an event to be selected by the local club. Four Star Commodores will receive a special lapel pin and a memento of their award and their club will receive a framed certificate to display the accomplishments of their selected Past Commodore.

## So What's Your Chapter Doing?

Some Chapters organize simply for the purpose of having lunch or dinner once a month. There's nothing wrong with that but, membership in your Chapter could be a lot more rewarding if you had a goal or goals beyond a meal.



Many Chapters are reluctant to get involved in club activities because it might be viewed as interfering with the current Commodore and his or her Board. However, we have all been Commodores and know there are areas we can become involved in that could be beneficial to the club without stepping on any toes.

Club functions is a major area where FCA Chapters can make a contribution. The most prominent event is the annual Change of Watch ceremony. You know there is a lot to do as the incoming CEO of the club and not having to worry about the Change of Watch would be a relief. Let's face it, nobody knows more about Change of Watch ceremonies than Past Commodores. We've all been through at least one and have probably attended many others.

Another function ideally suited for Past Commodores to run is the Sundowners Ceremony. FCA can supply you with all you need to know about this ceremony. The Sundowner Ceremony can be done every month or as few as a couple of times a year. In these times, when our troops are in combat, it invokes a real sense of pride on the part of the club's membership and if you send a release to the local press it garners very positive publicity for your club in the community.

Acting as the "charitable" arm of your club can also be the mission of your Chapter. This can be done in many ways such as running a "Toys for Tots" program at Christmas, or running a collection point for food donations for needy families during Thanksgiving or other times of the year. How about collecting personal care/comfort items for our troops in the war zone. One of the most successful programs we run is an Annual Ball and Silent Auction for the local Habitat for Humanity. Not only does it bring a very exclusive event to your club with a very positive public image, it also raises a lot of money for the charity!

Other ways your Chapter can provide support to your club is to develop a club history if one doesn't exist. Interviewing senior members, reviewing press clippings and harvesting facts from your Club newsletter can be the start of building or updating a club's history. Another way to provide a valuable service to your club is to run monthly or quarterly introduction programs for new members. Reviewing and clarifying your club's operating procedures, billing process, social and boating activities, dress codes and the facilities make for better informed and happier members.

These are just a few ideas to consider. While every club has different needs, every club has needs and your Chapter can make a valuable contribution in filling some of those needs. Perhaps your Chapter is already involved in some worthwhile club activities - if so, please let us know so we can share your contribution with other Chapters.



## LOCAL YACHT CLUBS SUPPORT The Centennial of Naval Aviation

Panhandle of Florida yacht clubs are helping host the Centennial of Naval Aviation Celebration which will be held on the grounds of Pensacola Yacht Club on Saturday, May 7, 2011. The clubs include the Pensacola Yacht Club (PYC), Navy Yacht Club Pensacola (NYCP), Grand Lagoon Yacht Club (GLYC), Fort Walton Yacht Club (FWYC), Point Yacht Club (PtYC) and Pensacola Beach Yacht Club (PBYC).

Pensacola Yacht Club was approached in 2010 about the possibility of helping host the 100<sup>th</sup> Anniversary of Naval Aviation. The PYC Commodore and Board enthusiastically agreed to support the celebration. The hosting support rapidly expanded to include all the yacht clubs on Pensacola Bay and three located in close proximity to Pensacola Bay including GLYC, PtYC, and FWYC. Of these six yacht clubs, three have very active FCA chapters. One of the events to be conducted during the celebration activities on May 7 will be the traditional Sundowner Ceremony which will honor all Naval Aviators.



Two of the key events on May 7 will be a Boat Parade of over 100 power

and sail boats that will Pass In Review of the USS Iwo Jima which the Navy has scheduled for a visit to Naval Air Station Pensacola in support of the celebration. In addition, the Pass In Review will honor a US Coast Guard Cutter which will be docked near the USS Iwo Jima. Following the Pass In Review, the boats will pass the docks at Pensacola Yacht Club for a traditional Blessing of the Fleet.

All six yacht clubs will have a booth located on the grounds of the Pensacola Yacht Club to provide information about their clubs. In addition, there will be a drill team performance, local high school and middle school bands will perform, and sailing demonstration seminars will be held for kids and their parents. The Celebration activities at Pensacola Yacht Club are opened to the general public as a community service to the area.

#### Past Commodore Richard L. Kelley, Jr

Dick, as he was known, died at the age of, 70, after a long battle with cancer attributed to exposure to Agent Orange during the Vietnam War. Dick was born in Westfield, MA and upon graduation from Boston College in 1962, he was commissioned a second lieutenant in the United States Army. Twenty years later he retired as a Lieutenant Colonel. Among various medals and awards he received the Legion of Merit Award.

Upon his retirement from the Army, he was employed by Pentagon Federal Credit Union from which he retired in 1993 as Vice President of Administration. Subsequently, he became the CEO of the Lawyers Credit Union in Miami, FL., from which he retired in 2004.

Dick served as Commodore of the Matanzas River Yacht Club, Treasurer of the Palm Coast Yacht Club and Vice Commodore of the Florida Commodores Association where he was a founding member. He was a member of the Msgr. Leo Gildea Council 7845, Knights of Columbus; VFW Post 8696; and more recently, the B.P.O.E. Lodge 2709.

Briggs passed away on December 27<sup>th</sup> at his home in Palm Coast FL. He was a young 81 years old and a true southern gentleman.





## Yachting and Regattas Custom or Tradition

John Matthews, Vice Commodore, FCA

In January, 2011, I was elected to serve as Commodore, Gulf Yachting Association. This association was founded in 1901 and reorganized in 1921 specifically to promote the sport of yacht racing on the Gulf Coast and in nearby areas.



The GYA has grown from the original six clubs, one of which is the Pensacola Yacht Club where I am a Past Commodore, to over thirty member yacht club organizations. These clubs range from St. Petersburg Yacht Club on the west coast of Florida to Houston Yacht Club on the east coast of Texas. Members clubs are located in Jackson, Mississippi; Birmingham, Alabama; and Little Rock, Arkansas in addition to the many yacht clubs along the Gulf Coast in Louisiana, Mississippi, Alabama, and Florida.

The Gulf Yachting Association is a member of the United States Sailing Association (USSailing), the governing body of the sport of yacht racing in the US. It is recognized as a member "yacht racing association" of that organization. As such, the GYA provides representation to USSailing for its sailors, runs elimination events for national champion-ships sanctioned by USSailing, and provides an Appeals Committee to decide appeals involving the racing rules of sailing, the rulebook produced by the International Sailing Federation (ISAF). This rulebook governs the conduct of all sailboat racing regardless of where the racing is conducted in the world. All of us in the United States are familiar with the America's Cup. It is sailed and subject to these rules of racing just as much as the local club championship held at Pensacola Yacht Club is governed.

The GYA is structured with a Board of Directors that consist of each of the sitting Commodores of the member yacht clubs as the senior body. The Board has full authority to govern the organization. In addition, there is the Executive Committee that runs the organization between meetings of the Board; four councils that promote specific types of yacht racing including offshore, one design, and multihull; and various committees to accomplish the work of the organization. The GYA has produced several Olympic sailing competitors including John Dane, the oldest Olympic competitor ever, who sailed in the 2009 Olympics held in China.

Of course, not all yacht clubs are involved in yacht racing. However, I bet that every sailor in a yacht club that has ever sailed a yacht has had the temptations to race if only to "compete" against a fellow sailor on the bay at the same time. It has been said that when two sailboats appear in proximity on an open body of water, the "clicks" of the wenches can be heard as the sail trim begins and the "competition" is underway. It is all in fun.

Yacht clubs that support the sport of racing are committed to the sport. Many of the FCA yacht clubs are involved with supporting yacht racing. Most are committed to getting their junior sailors involved with sailing through the competition offered by sailboat racing whether it be one design races such as Optimist Dinghies, Flying Scots, or Lasers or by racing on monohull PHRF racing sloops or multihulls such as Corsairs or Vipers or Hobicats. Racing creates leadership, team work, self discipline and sportsmanship, the traits needed by all young people as they grow and develop into mature adults. Such outstanding adult sailors include Randy Smythe, Ted Turner, Dennis O'Conner, Gary Jobson, and Larry Eliason, all leaders in their own right.

I have had the pleasure to serve on numerous race committees. This is the group of dedicated sailors that "run the races" for the competitors. In addition, I have had the honor to serve as the Principal Race Officer for many regional and local races and regattas including the biannual race to Isla Mujeres, Mexico from Pensacola, Florida. One of the most important races within the GYA is the annual Sir Thomas Lipton Challenge which challenges the member clubs of the GYA to determine which yacht club team is the best sailing in the Flying Scot. The Sir Thomas Lipton Challenge was created to honor Sir Thomas Lipton, the founder of the Lipton Tea Company, and who donated the sterling silver trophy to the GYA for the winner of a regatta recognizing the best yacht club team in the GYA.

Sailboat racing is not the answer to every person's desire to sail boats. However, it is one way to rapidly learn the ins and outs of sailing under demanding and stressful conditions. These conditions will appear during any outing while sailing especially when they occur when least expected. It is always better to be prepared to meet these conditions and practice them than finding you need to know how to handle them and you have never dealt with them. Sailboat racing is a great training ground for all sailors. You do not have to win just to learn how to handle your sailboat better and be prepared for the unknown on the water.

Whether you go sailing just to spend a quiet day on the water, cruise your boat to a distant port, or compete in a regatta, sailing will continue to be challenging and provide the opportunity to spend quality time on the water. Remember the old adage, "A bad day on the water is better than a good day at work".

I venture to say that in the majority of cases where there has been a leader in a yacht club elected to serve as Commodore there has been a very special person connected to that Commodore that is a spouse, lover, or domestic partner. This person is particularly special to the Commodore who serves as his/her confidant, trusted friend, or reliable counsel; a person with special talents, a good listener, communicator, a great deal of experience and knowledge relating to management, and one who is committed to the same ideals as the Commodore. They are there to support the Commodore and to ensure his/her success.

The founders of the Florida Commodore's Association and the International Commodore's Association addressed the issue of how to improve the organizations from the very beginning over what we had been associated with prior to the formation of these two associations. We overwhelmingly agreed that we need a source of counsel, advice and some good old "horse sense" from those that had played a critical role in the a Commodore's successful tenure at the helm of a yacht club. We decided to incorporate Associate Members into both organizations as a way of accomplishing this action. Spouses and domestic partners seemed to be a fitting choice for achieving this goal.

As we thought about Associate Members and who might be another good choice for this category, we came to the realization that if the FCA and ICA were to achieve their stated Vision and Mission we would have to look at how these two groups could best provide useful advice and counsel and hands on knowledge to yacht club leaders of the future. It was then that the founders agreed that serving Commodores, Vice Commodores, and Rear Commodores should be permitted to join the organizations as Associate Members. Such membership would explicitly promote the belief that the organization would be able to provide the knowledge, experience, and expertise from Past Commodores to those leaders that would be serving or expected to serve their individual yacht clubs currently and in the future. It becomes a Win-Win situation for Past Commodores and Present and Future Commodores. Sharing what has been experienced and learned with those who have yet to face the myriad of challenges of serving as a Commodore.

Both the FCA and the ICA encourage their chapters and regional groups to identify and promote the addition of qualified Associate Members to their ranks. It is a very strong avenue for these organizations to ensure that all yachting customs and traditions are well maintained and available for future generations to use and experience.


### Help Wanted: FCA Area Ambassadors

## Bottom up

FCA immediate Past Commodore Ron Richards frequently mentions that FCA is a bottom up not a top down organization. Those in attendance at the organizational meetings in Gainesville a few short years ago, can attest to bottom up, along with one man one vote, as being among the cornerstones of the FCA.



Another important decision that came out of those meetings is the status of asso-

ciate members. Members in this category have all the privileges of membership with the exception of voting. Only Past Commodores, who hold a regular FCA membership, may vote. Associate members are defined as spouses, significant others and sitting Commodores, Vice Commodores and Rear Commodores.

What this means to you is, associate members are encouraged to participate in membership meetings and have their voices heard on any topic that comes before the Executive Committee. If you have attended an FCA general membership meeting you will see this occurring. If you haven't attended, you are encouraged to do so.

I have noticed a disappointing lack of memberships for associate members. These members are very important at both the Chapter and FCA level. At the Chapter level, associates wear many different hats.. They assist in social functions, fund raising, etc. At my home club, Fort Walton, the Chapter By-Laws were recently amended to allow an associate member as a non-voting Secretary/Treasurer of the Chapter.

This is another way to increase participation. Having the sitting Club Flag Officers as part of your Chapter is also a definite asset. This can be an excellent opportunity for members to interact with the Club Officers in an informal session, perhaps a monthly Chapter lunch as we do at FWYC. Get involved, the FCA wants and needs your participation.
